Dear TFS Families,

As we prepare for the 2025-26 academic year, we are committed to safeguarding the health and safety of every student through the necessary annual requirements within the Magnus Health System. You can access Magnus through the Parent Portal on the Medical tab or by clicking the link below: https://secure.magnushealthportal.com/front_desk.jsf.

To ensure a seamless transition to the TFS campus for the upcoming school year, all annual requirements must be completed, dated, and uploaded between April 1 and June 15. All required documents must be submitted by the June 15th deadline. Completing these requirements is essential for your child's full participation in school activities and trips. We ask for your prompt attention to this critical matter. This is a vital part of your student's enrollment.

Here are a few key reminders to keep in mind:

1. The GIAA Preparticipation Physical Evaluation (Activities Physical) consists of four pages. This form is needed for ALL students for school attendance. Ensure all pages are filled out and the student and a parent/guardian sign and date the history portion. Your provider will complete, sign, and date the last two pages. This is classified as a physical activity form and should be done between April 1st and June 15th of the current year. Remember to take a copy of this form to the provider to complete, as we can only accept this form for your student's records.

2. For The Conditional Questions, if you answer "yes" regarding allergies, seizures, or asthma, complete ALL the appropriate forms with your provider and upload them. If your student does not use rescue medications but has allergies, seizures, or asthma, then it should be documented.
3. The State of Georgia requires that immunizations be kept current according to Georgia state requirements, and the school must be provided with proper documentation. This is a vital part of your student's medical records. (Georgia Form 3231, TFS Form or Medical/Religious Exemption Form)

The following required forms should all be completed electronically for all students no later than June 15th:

- **Conditional Question**
- **Vital Health Records**
- **Consent to Medical Treatment**
- **GIAA Concussion Awareness Form**
- **GIAA Cardiac Arrest Form**
- **Over-the-Counter Medications**
- **Upload copies of both the front and back of the insurance cards**
